Dancers will be dismissed at the end of the cohort session. A staff member will be signing out dancers as they are picked up. Please be on time to collect your dancer. *(a small number of classes will be given a different specific pick-up time - they will be contacted directly)*

**IMPORTANT** - At drop-off and pick-up, please only have ONE adult accompany your child to the door. After the registration process is done, we kindly ask you to please leave the area . Do not congregate at the doors. Do not congregate in large groups. Please wear a mask outside while dropping off and waiting for your child.

**PARENTS** - please wear a mask outside the theatre while dropping-off & picking-up your dancer. Please social distance from other families as well. Please help your dancer to follow distancing and mask rules.

**DANCERS** - you **MUST** wear your mask at ALL times, including on stage. You must social distance as much as possible. Please be sure to stay in your square of space while waiting to perform, and keep your belongings to yourself - in your designated area.

MDE & The Act Theatre will be strictly following the protocols approved by Fraser Health. Please do your part to ensure all safety guidelines are followed, and to withhold MDE's good reputation.
